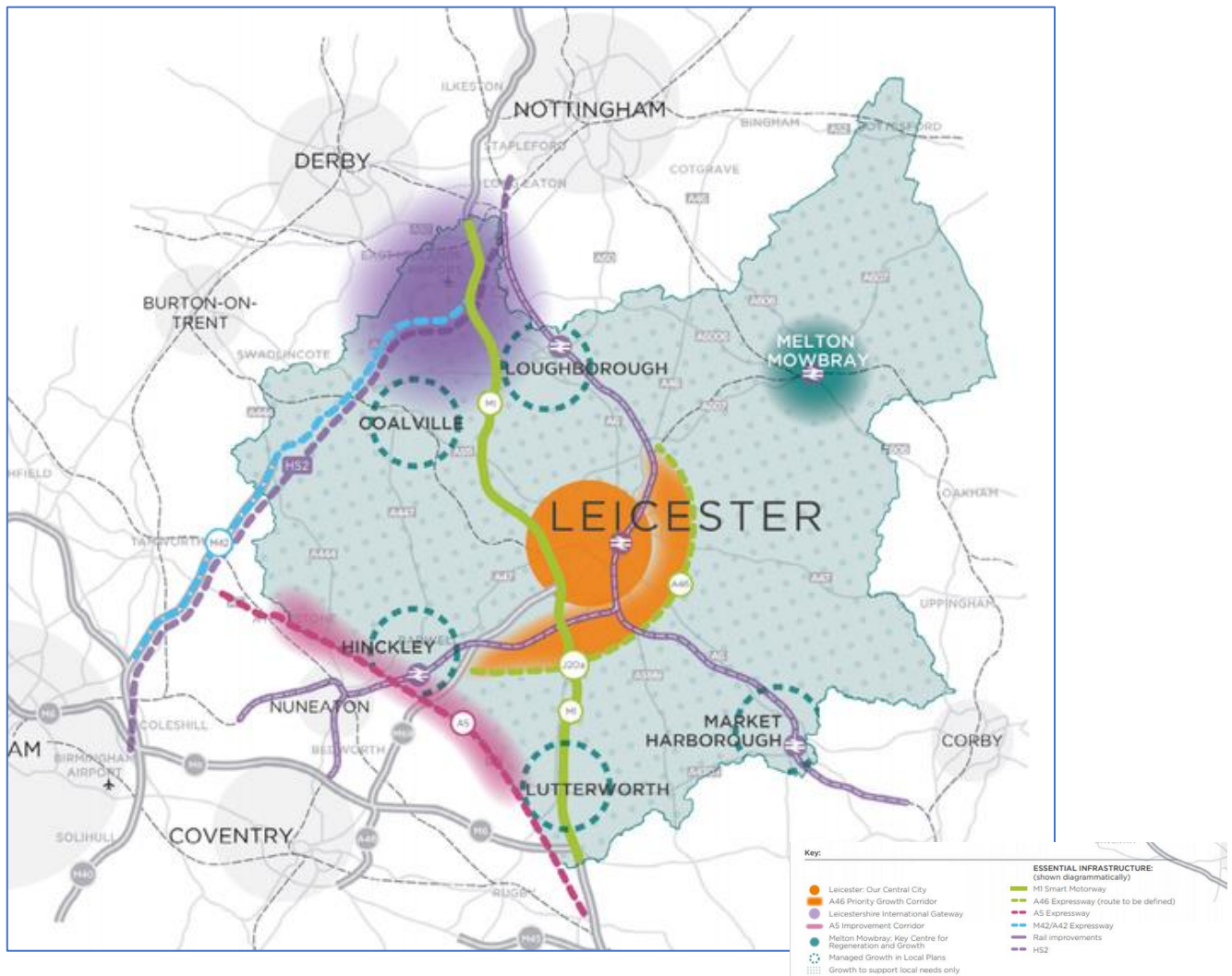


# THE PROPOSED A46 EXPRESSWAY

## An Invitation to residents of affected Parishes to OPPOSE this plan

7.00pm at Coplow Centre, Billesdon on 4<sup>th</sup> April 2019

The 60 Parishes on the attached list would be affected either directly or indirectly by the implementation of the Leicestershire Councils' approved Strategic Growth Plan (SGP). This includes the construction of a new 70 mph Dual Carriageway Expressway from Junction 2 of M69, via a new junction J20A on the M1, through Blaby, Harborough and Charnwood Council areas around South and East Leicestershire, linking to the A46 at Syston. In addition, 38,000 new homes and huge Employment Developments are proposed within the orange arc area on the plan below-



This is not a theoretical Plan. There are already proposals for a huge “Garden Village” between Countesthorpe, Cosby and Willoughby Waterleys and a new J20A on the M1.

In addition, Midlands Connect will be publishing the results of their Optioneering Study into upgrading A46 trunk route from Gloucester to Immingham in the Spring. This will include analysis of the bypass options for routes around Leicester as a part of the proposals. The SGP chooses a South and East bypass around Leicester but we consider that there are other options and question the need for the fully upgraded A46.

If the Midlands Connect report also recommends a South and East bypass route there will be real commitment and momentum to large-scale development along the whole route supported by all the Leicestershire Councils - County, District and City.

There are alternative approaches, which should be tested before any commitment is given, but there is no evidence that these are being investigated by any of the Councils. We need to challenge this NOW if the SGP implementation is **to be halted**.

#### **FURTHER INFORMATION:**

CPRE Leicestershire has been challenging the SGP and A46 Expressway proposals through detailed investigation since 2017. The South and East Leicestershire Action Group (SELAG) has been formed by concerned residents who also oppose the proposals. Residents of Willoughby Waterleys have formed Willoughby Waterleys Residents' Association (WWRA) as the proposals for huge housing and logistics development at Whetstone Pastures on their doorstep is forging ahead.

These three organisations have come together to seek support from all the Parishes and Villages along the potential route of the new A46 Expressway who would be affected by this **MASSIVE** development proposal.

Parish Councils were invited to a meeting 12 months ago organised by CPRE Leicestershire during the SGP Consultation. Parishes on the attached list are now invited to a further meeting where updates will be given, the implications of doing nothing explained and how policies can be challenged, and alternatives considered.

This is not a normal small local issue. **IT WILL AFFECT THE WHOLE OF SOUTH AND EAST LEICESTERSHIRE.**
